

## Client Service Agreement

This agreement is made and entered into on \_\_\_\_\_ (date) between \_\_\_\_\_ (hereinafter referred to as "law firm") and WebLegalMarketing.com (hereinafter referred to as "WLM").

### Services Provided

- a) WLM shall provide internet property development and marketing services to assist in the client development process for law firm
- b) Although online property will be customized to have the appearance of ownership of by the client law firm, WLM shall retains ownership, unless otherwise agreed, of any and all online property and accounts initiated and developed by WLM, examples may include but are not limited to websites, blogs, Squidoo lenses, Hubpages, Youtube channels, Facebook Accounts, email accounts, Twitter Accounts, Google Places Accounts and videos.
- c) WLM shall undertake to drive targeted visitors to these properties with the intention of creating one of three measurable outcomes initiated by a potential client.
1. A telephone call to a stipulated local phone number directly to the law firm of a duration of at least 30 seconds or
  2. Completion and submission of an online "bankruptcy information request form" containing personal contact information received directly by the law firm
  3. A direct request via email from more information originating from a WLM controlled property
    - Law Firm Shall have immediate access to all inquiries.
- d) WLM shall provide these services exclusively for law firm in a designated geographic area for a specific practice area.

### Administration

- e)Billing: WLM will provide an online monthly summary of telephone, email and online inquiries from "c" within 48 hours of the end of the month in which they occur
- Payment is due upon receipt
  - Law firm may dispute the charges related to data available via online document deemed as unreliable due to 1)duplication or 2)fraudulent contact information, within 5 days of availability of month-end summary.
  - Law firm shall pay a total of \$50 for each contact provided as defined in "c" and included on the monthly billing statement. The \$50 is comprised of a \$35 "property lease" and \$15 "marketing services".

f) Deposit: As consideration for market exclusivity and online property development and customization Law Firm shall make a non-refundable deposit of \$1,000. This shall remain on deposit until agreement is terminated and will be applied to the final billing at such time.

g)TERM: The term of this Agreement will begin upon acceptance by both Law Firm and WLM and will end when terminated by either party pursuant to this Agreement. Either Law Firm or WLM may terminate this Agreement at any time, with or without cause, by giving the other party written 30 days written notice of terminate.

- Law firm shall remain responsible for payment of all contacts identified in “c” above for 30 days following termination.
- WLM shall remove all customized law firm information from related properties within 30 following termination.

h)Client to provide requested information to facilitate the “customization” of the host properties
